JIMAR PIRO ENDANGERED SPECIES BIOLOGIST – ID# 28672. School of Ocean and Earth Science and Technology. Joint Institute for Maine and Atmospheric Research. Regular, Full-Time, RCUH Non-Civil Service position with the School of Ocean and Earth Science and Technology (SOEST), Joint Institute for Maine and Atmospheric Research (JIMAR), located at the National Marine Fisheries Service (NMFS), Pacific Islands Regional Office (PIRO), in Honolulu, Hawaii. Continuation of employment is dependent upon program/operational needs, satisfactory work performance, and availability of funds. **MINIMUM MONTHLY SALARY:** \$3,222/month. **DUTIES:** Position involves the implementation of the federal Endangered Species Act (ESA) in the Pacific Islands region (Hawaii, American Samoa, Guam, Commonwealth of the Northern Marianas, and Pacific Remote Island Area) as follows: (1) Leads ESA section 4 projects, such as responses to petitions to list species and/or designate critical habitat, and planning of public meetings and public comment periods; and (2) conducts or assists with ESA section 7 informal and formal consultations, technical assistance projects, and species lists. In addition to ESA work, the incumbent will also organize species information for the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) Program, and work with a variety of stakeholders in the Pacific Islands region to promote species conservation. **PRIMARY QUALIFICATIONS: EDUCATION:** Bachelor's Degree from an accredited four (4) year college or university in Natural Resources, Environmental Science, or a related field. **EXPERIENCE:** Three to five (3-5) years of experience in areas of natural resource management which includes the performance of technical assignments according to established protocols, and reporting results; and working with diverse community constituencies to implement policy and management through established protocols. **ABIL/KNOW/SKILLS:** Demonstrated knowledge of the Endangered Species Act, other federal environmental laws, and policies related to marine protected resources. Knowledge of databases and computer applications. Demonstrated abilities in following scientific protocols and reporting on scientific data and information.
